

ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION
of
SUNRISE AT TOMA RIDGE PROPERTY OWNERS ASSOCIATION, INC.

Pursuant to the provisions of Sections 30-325, 30-326 and 30-327 of the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is SUNRISE AT TOMA RIDGE PROPERTY OWNERS ASSOCIATION, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the members of the corporation on the 30th day of October, 1989, in the manner prescribed by the Idaho Non-Profit Corporation Act:

That Article IV is amended to add the following subsections:

(h) To acquire and own real estate and personal property including sewer system (for townhouses only), water rights, water lines, mains, easements, pumps, pumping fixtures and equipment, water licenses and permits, franchises and any other property, item or effect that may become instrumental for the purposes for which the corporation is organized.


(i) To supervise, manage, distribute, control and supply water to the members of the corporation and to supervise, manage and control the sewer system (for townhouses only) and water sources and systems and conduct all business necessary or instrumental to the same.

THIRD: That a quorum of the members was present at such meeting, and that such amendment received at least a majority of the votes of the members present at such meeting in person or by proxy were entitled to cast, as well as a majority vote of those members present in person or by proxy of any class entitled to vote as a class thereon by the terms of the Articles of Incorporation or by the by-laws.


