The undersigned, for the purpose of forming a corporation under the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I.

The name of this Corporation is **KB ENTERPRISES, INC.**

ARTICLE II.

The period of existence and duration of the life of the Corporation shall be perpetual.

ARTICLE III.

The purpose for which said corporation is formed is to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including but not limited to all.

Section 1. This Corporation shall be authorized to issue one class of shares of stock to be designated "common stock". The total number of shares of stock which this Corporation shall be authorized to issue is 1000 shares of no par value stock.

ARTICLE VI.

Section 1. The number of directors constituting the initial Board of Directors shall be one (1).

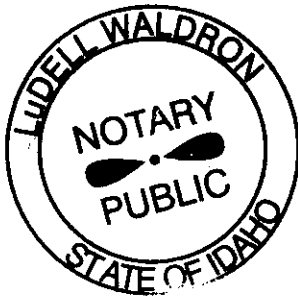
