ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, cities of the United States of America, all over the age of eighteen year mave this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we certify in writing:

I.

That the name of the corporation shall be M-LEE, INC.

II.

That the purpose for which said corporation is formed is to ensage in the operation of a Bookkeeping Service using a tyle, system, and method of operation to be developed by the officers and stockholders of the corporation or other persons; to sell or purchase its own stock, or to sell and purchase the corporate stock of any other corporation; to take, own, and held mortgages, trust deeds or other liens; to own real and personal property and to dispose of same in any manner that may be necessary for the benefit of said corporation; to enter into, make and perform contracts of every kind and with any person, firm, association or corporation, municipality, State Gov imment or colony or dependency thereof, and without limit as to amount; to accept, endorse, discount, execute and issue promissory notes, $d\epsilon$ fits, bill of exchange, bills of sale, bulk sale, bulk sales agreements, war ants and other negotiable or transferable instruments, and to secure the same by mortgage, trust deed, chattel or otherwise, so far as may I permitted by laws of the State of Idaho, and to do all things necessary and covenient in carrying out the purposes for which this corporation is organ: and especially to exercise all of the powers and rights granted to general bus ass corporations under the laws of the State of Idaho pertaining thereto at the issuance of a certificate of incorporation to these incorporation

III.

That the term for which said corporation is to exist is perposed.

That the principal office and place of business of said corporation is the City of Pocatello, County of Bannock, State of Idaho.
