### ARTICLES OF AMENDMENT TO THE

#### ARTICLES OF INCORPORATION

OF

# SUNBIRD AIR, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is SUNBIRD AIR, INC.

SECOND: The following amendment of the Articles of Incorporation were adopted by the shareholders of the corporation on May 19, 1989, in the manner prescribed by the Idaho Business Corporation Act:

That Article I of the Articles of Incorporation of Sunbird Air, Inc., be amended to read as follows:

## "ARTICLE I

NAME. The name of the corporation is, SWEENEY AIR TRANSPORT, INC."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

FOURTH: The number of shares voted for such amendment was 100; and the number of shares voted against such amendment was -0-.
