ARTICLES OF INCORPORATION

and SWEN L. O'DONNELL, the undersigned, full age citizens of the United States, this day, for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, do hereby certify:

ARTICLE I.

That the name of the corporation shall be O'DONNELL PHARMACEUTICAL MANAGEMENT, INC.

ARTICLE II.

The purposes for which the corporation is organized shall be, and include, the transaction of any and all lawful business for which a corporation may be incorporated under "The Idaho Business Corporation Act." The specific purpose for which the corporation is organized is to have pharmacy ownernship, management, and to provide pharmaceutical expertise and services to other entities.

ARTICLE III.

This corporation shall have perpetual existence.
