We, the undersigned persons, acting as the incorporators of a non-profit corporation under the provisions of the Idaho Non-profit Corporation Act (Title 30, Chapter 3, Idaho Code), adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation is: Latah County Adult Literacy Council **INC.**

ARTICLE II
NON-PROFIT STATUS

The corporation is a non-profit corporation and shall be composed of members not shareholders.

ARTICLE III
DURATION

The period of duration of this corporation shall be perpetual.

ARTICLE IV
PURPOSE

The purpose of the corporation is to improve adult literacy in Latah County by:

1. Recruiting and tutoring adults in reading and writing.
2. Providing training and inspiration to tutors on a regular basis.
3. Encouraging communication and cooperation among other literacy programs.
4. Making referrals to other programs and resources when appropriate.
5. Encouraging and facilitating development and/or extension of programs as needed.
6. Promoting interest and cooperative efforts of the citizens and the community in the activities of the Council.
