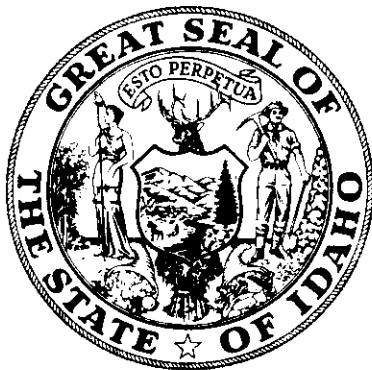

ARTICLE I


The name of the corporation shall be COMMUNITY BIBLE CHURCH, INC.


