



RE: Use of the word "Bank" in company name in Idaho

Dear Mr. Dallal:

The Idaho Department of Finance (Department) received your email on November 30, 2020, directed to Mary Hughes. Ms. Hughes has retired from the Department and, in the future, you may direct your emails to me at [salvador.cruz@finance.idaho.gov](mailto:salvador.cruz@finance.idaho.gov). You request approval by the Department as to the use in Idaho of the company name "Mortgage Bank of California, Inc." and the assumed business name "mbanc, a mortgage lender" (MBOC).

As you correctly note in your request, the Department granted you the right to use these names in a letter from Ms. Hughes, dated October 23, 2018. The Department reached the conclusion that these names, subject to one condition, would allow for the Department to grant a waiver pursuant to Idaho Code § 26-1202. The only condition imposed by the Department, as you note in your email, is that any reference to mbanc be accompanied, in close proximity, by the prominent disclaimer that mbanc is not an insured depository institution, or words to that effect.

The Department is unaware of any reason to prevent the continued use of these names and therefore, in accordance with Idaho Code § 26-1202, grants a waiver to Mortgage Bank of California to use the name "Mortgage Bank of California, Inc." in MBOC's mortgage lending business in Idaho and advertising related thereto. Additionally, the Department hereby grants a waiver to MBOC's use of the name "mbanc, a mortgage lender" subject to the condition that MBOC reference it elsewhere on the page that "mbanc is not an insured depository institution" or words to that effect.
