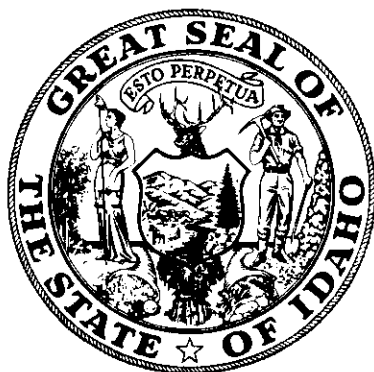

1. The name of the corporation is CASCADE TRANSFER, INC.

2. The period of its duration is perpetual.

3. Its purpose is to transact the business of a common carrier as defined by Section 61-113, Idaho Code, excavating and earth moving, general construction, snow removal and all other business not forbidden by law.

4. It shall have authority to issue Five Thousand (5,000) shares, all of one class, One Dollar (\$1.00) par value.
