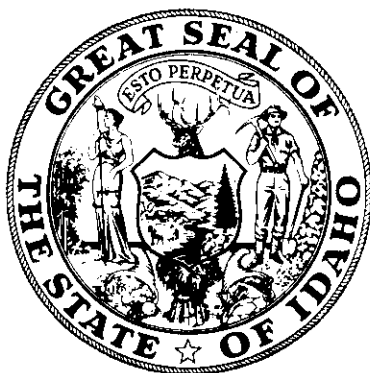

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, a natural person of full age, citizen of the United States of America and resident of the State of Idaho, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

I.

The name of the corporation shall be PAIR-A-DICE, INC.

II.

The term for which said corporation shall exist shall be in perpetuity.

III.

The objects and purposes for which this corporation is organized shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The capital stock of this corporation shall consist of Ten Thousand (10,000) shares of nonassessable, common stock, with \$1.00 par value.

V.

The shareholders of the corporation shall not have preemptive rights.

VI.

The location and address of the initial registered office of this corporation in the State of Idaho shall be 120 Central Middleton Road, Nampa, Idaho, 83651. The initial registered agent of this corporation is Carl D. Dice and his address is 120 Central Middleton Road, Nampa, Idaho, 83651.

The business of this corporation shall be managed and conducted by a Board of Directors of initially four (4) Directors. The initial Directors shall be as follows


