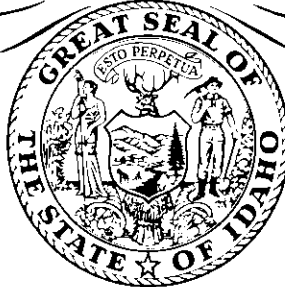

CERTIFICATE OF AMENDMENT  
OF  
ARTICLES OF INCORPORATION

Know all men by these present, that the President and Secretary, respectively, of the Idaho Retailers Association do hereby certify that at a special meeting of the membership, duly called, held in Sun Valley, Idaho on September 20, 1971 for the purpose of amending the Articles of Incorporation of said corporation, it was voted and unanimously adopted by the membership that the following amendments to the Articles of Incorporation of the Idaho Retailers Association be changed as follows:

ARTICLE I.

Name

The name of the corporation shall be "IDAHO RETAILERS AND FOOD DEALERS ASSOCIATION, INC."

ARTICLE III

Purposes

The purposes and objectives of the IDAHO RETAILERS AND FOOD DEALERS ASSOCIATION shall be purely benevolent and educational and shall not be for pecuniary gain or pfoit. These purposes and objectives are as follows:

(a) To conduct a service program in behalf of the retail industry of Idaho.

(b) To promote unified action by all segments of the retail industry in matters that are of common interest, to the end that retailers may better serve the public.


(c) To provide non-partisan and non-political representation to all brokers of retailing -- independent and chain, small and large.


(d) To cooperate with other state and national groups and with non-retail groups, such as educational organizations, farm organizations, chambers of commerce, on matters of common interest that affect the conduct of retailing; and on prggrams that strengthen and develop the state's agricultural and industrial economy.

(e) To serve as a factfinding bureau to collect, analyze and interpret all available data related to retail distribution, and to translate these facts to Idaho retailers and other organizations; and to cooperate with both the Legislative and Executive branches of the State and Federal Government to the end that retailers may better serve the public.

(f) To do other acts that may tend to benefit the retail industry as well as producers and consumers of goods, wares and merchandise.
