KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of full age, a citizen of the United States of America, and a resident of the State of Idaho, do voluntarily sign these Articles for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and I hereby certify as follows:

ARTICLE I

The name of this corporation shall be TERRA-TRON, INC.

ARTICLE II

The purpose for which this corporation is formed is to carry on any lawful business, which shall not be held to limit or restrain in any manner the general powers now or hereafter conferred on this corporation by the statutes of the State of Idaho.

ARTICLE III

The existence of this corporation shall be perpetual.

ARTICLE IV

The principal office or place of business of this corporation shall be at 7614 Lemhi, Suite 2, Boise, Ada County, Idaho, but the corporation may maintain an office in such towns, cities and places outside the State of Idaho as the Board of

Directors may from time to time determine, or as may be designated by the By-Laws of the corporation. The registered agent at said office is Barry R. Hudson.

#### ARTICLE V

The total amount of the authorized capital stock of this corporation is \$10,000.00 consisting of 10,000 shares of common stock with a par value of \$1.00 per share.

#### ARTICLE VI

The members of the governing board of this corporation are styled "Directors", and the Board of Directors shall consist of at least one (1) and not more than seven (7), as may be provided by the By-Laws of the corporation.

#### ARTICLE VII

The capital stock of the corporation shall be nonassessable; and the private property of the shareholders of this corporation, and each of them, shall not be subject to assessment nor be liable for the debts, obligations or liabilities of this corporation.

#### ARTICLE VIII

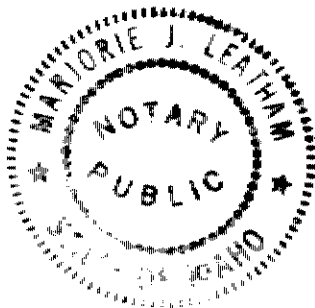
