ARTICLES OF INCORPORATION SELECTION

KNOW ALL MEN BY THESE PRESENTS that ELMER WRIGHT and DIANA WRIGHT, each being of the age of eighteen (18) years or more, do hereby associate themselves for the purpose of forming a business corporation under the laws of the State of Idaho, and do hereby adopt in duplicate the following Articles of Incorporation:

ARTICLE I

Corporate Name

The name of this Corporation shall be WRIGHT LOGGING, INC.

ARTICLE II

Corporate Duration

The period of duration of this Corporation shall be perpetual.

ARTICLE III

Corporate Purposes

This Corporation is organized for the purpose of the transaction of any or all lawful business for which corporations may be incorporated.

ARTICLE IV

Stock

The aggregate number of shares of Authorized Shares. Section 4.01 stock authorized and which may be issued by this Corporation is fifty thousand (50,000) shares of common stock of the par value of One and no/100 (\$1.00) Dollar per share.

The Board of Directors of this Section 4.02 Issuance in Series. Corporation shall have the authority to divide any or all of the shares of this Corporation into series and, subject to such limitations as may be set forth in applicable Idaho Code, or any substitute therefore or amendment thereto, the Board of Directors of this Corporation shall have the authority to fix and determine the variations in the relative rights and preferences of the shares of any series so established.

Section 4.03 <u>Preemptive Rights</u>. The shareholders of this Corporation shall not have the preemptive right to acquire additional shares of stock of this Corporation.

Section 4.04 Restriction on Transfer of Stock. No shareholder shall transfer, assign, sell, pledge, hypothecate, or otherwise dispose of the shares of stock of this Corporation or the certificates of stock representing the same, or of any interest therein, without first complying with such conditions and restrictions as may be established in the Bylaws of this Corporation and, if a Stock Purchase Agreement between this Corporation and its shareholders is then in effect, complying with such additional conditions and restrictions as may be provided therein.

ARTICLE V

Directors

Section 5.01 <u>Number of Directors</u>. The number of directors of this Corporation shall be fixed by the Bylaws of this Corporation; provided, however, that the number of directors shall not be less than the number required by statute.

Section 5.02 <u>Initial Board of Directors</u>. The number of directors constituting the initial Board of Directors of this Corporation is two (2), and the names and addresses of the persons who are to serve as the initial directors until the first annual meeting of shareholders of this Corporation or until the election and qualification of their successors are:

Section 5.03 <u>Powers of Directors</u>. The business, affairs and powers of this Corporation shall be managed by or under authority of the Board of Directors. In the management and control of the business and affairs of this Corporation, the Board of Directors is hereby vested with all of the

powers possessed by this Corporation itself, so far as this delegation of authority is not inconsistent with the laws of the State in which this Corporation is incorporated. The power to alter, amend, or repeal the Bylaws of this Corporation, or to adopt new Bylaws shall be vested in the Board of Directors, subject to the power of the shareholders to alter, amend, or repeal any Bylaw so adopted.

ARTICLE VI

Registered Office and Agent

Ratification by Shareholders

Any contract, transaction, or act of this Corporation or of the directors or of any officer of this Corporation which shall be ratified by a majority of a quorum of the shareholders of this Corporation at any meeting of shareholders shall, insofar as permitted by law, be as valid and binding as though ratified by every shareholder of this Corporation.

ARTICLE IX

or hereafter prescribed or permitted by law. All rights of the shareholders in this Corporation are granted subject to this reservation.

ARTICLE X

Consent to Serve as Registered Agent

By signature hereto affixed, BLMER WRIGHT hereby consents to serve as registered agent, in the State of Idaho, for this Corporation, and understands that as agent for this Corporation, it will be the responsibility of said agent to receive service of process in the name of this Corporation; to forward all mail to this Corporation; and to immediately notify the office of the Secretary of State in the event of the resignation of said agent, or of any change in the registered office address of this Corporation.
