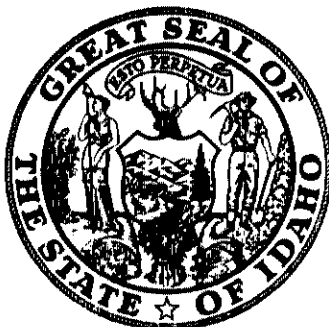
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

MESSERSMITH, INC.

The undersigned, acting as incorporators of Messersmith, Inc., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is: MESSERSMITH, INC.

**SECOND:** The period of existence and duration of the life of this corporation shall be perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized are:

(A) To carry on any kind of business or business activities that the shareholders may from time to time deem to be advisable or proper in connection with the business.

(B) To transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**FOURTH:** The aggregate number of shares which the corporation shall have authority to issue is:


