

hereby incorporate pursuant to the Laws of the
State of Idaho providing for the formation of
corporations for profit, for the purpose and with
the powers hereinafter stated.**

I

The name of the corporation is:

**The general nature of and purpose of this
corporation shall be the operation of residential
and commercial maintainance and repair bussiness
specializing in mobile home repairs and the
performance of any and all activities generally
associated thereto; and also**

**To engage in any activity or bussiness

**The existance of the corporation is to be






