THE CHURCH OF EVERLASTING LIFE, INC.

In compliance with the requirements of the Idaho Non-Profit Corporation Act, now set forth in Chapter 3, Title 30, Idaho Code, the undersigned, all of whom are of legal age, have this day voluntarily associated ourselves together for the purpose of forming a nonprofit corporation under the laws of the State of Idaho and pursuant thereto certify as follows:

ARTICLE I

The name of this nonprofit corporation is The Church of Everlasting Life, Inc. hereinafter called the "Church".

ARTICLE II

The principal office of the "Church" is initially located at 3477 Payne Place, Boise, Idaho 83704, the initial mailing address being the same. The office may be changed to a different location by action of the membership or by the Board of Directors of the Church.

ARTICLE III

The Rev. Marilyn Crase, whose address is 3477 Payne Place, Boise, Idaho 83704, is initially appointed as the registered agent of this Church with offices located at the same address.

ARTICLE IV

Purposes and Power of the Church

This Church is not formed for the purpose of pecuniary gain or profit to the members thereof and is formed as a nonprofit corporation. The specific purposes for which it is formed are, to promote, encourage and foster the development of the lines of communication between an individual and The Creator, God, His Son, Jesus Christ, and the Everlasting Spirit on Earth, and to promote spiritual alignment with such Spiritual Beings, and to render such services and to all lawful acts which may be deemed necessary, expedient or appropriate for the accomplishment or furtherance of or in connection with these purposes. Pursuant to such purposes the Church shall have the authority to have and exercise any and all powers, rights and privileges which a corporation organized under the Nonprofit Corporation Act of the State of Idaho by law may now or hereafter have or exercise.

#### ARTICLE V

##### Membership

The qualifications for membership, and the manner of selecting members, shall be governed by by-laws to be adopted by the incorporators. The by-laws shall be subject to amendment, from time to time as provided by law, and by the Board of Directors, in such manner as they may prescribe.

#### ARTICLE VI

##### Board of Directors

It shall be governed by a board of directors or trustees, and they shall be known and designated as "trustees", to be appointed by its members in such manner, and for such terms of office, as shall be prescribed in its by-laws; Provided,

however, that the number of trustees shall not be less than three.

The name and address of the principal organizer is Rev. Marilyn Crase, 3477 Payne Place, Boise, Idaho 83704. The other two board of directors are: Ray Wilson, 345 108th Avenue South East, Bellevue, Washington 98004, and Sam Wilson 3477 Payne Place, Boise, Idaho, 83704.

#### ARTICLE VII

##### Dissolution

The Center may be dissolved with the assent given by a unanimous vote of the voting members present at a lawful meeting. Upon dissolution of the Church, other than incident to a merger or consolidation, the assets of the Church shall be dedicated to Planned Parenthood of Idaho, Inc. In the event that such dedication is refused acceptance, such assets shall be granted, conveyed and assigned to a nonprofit corporation, association, trust or other organization to be devoted to such similar nonprofit purposes, or as designated by the Board of Directors.

#### ARTICLE VIII

##### Duration

The corporation shall exist perpetually.

#### ARTICLE IX

##### Amendments

These Articles of Incorporation may be amended by vote of two-thirds of the voting membership of the Center present at a meeting lawfully called and conducted under these articles and under existing by-laws.
