ARTICLES OF INCORPORATION OF SUN VALLEY-KETCHUM CHAMBER OF COMMERCE Liling.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is: SUN VALLEY-KETCHUM CHAMBER OF COMMERCE, INC.

ARTICLE II

The corporation is a nonprofit corporation

ARTICLE III

The period of duration of the corporation shall be perpetual.

ARTICLE IV

The purposes for which the nonprofit corporation is organized are: to promote, organize and encourage educational, business and cultural activities within the Sun Valley, Ketchum, Idaho area; to procure advertising in regional and national publications for the promotion of area tourism; to promote the common business interests of its members; to do all acts and things as permitted under Section 501(c)(3) of the Internal Revenue Code 1951, as the same now exists or as it may be amended from time to time.

ARTICLE V

The nonprofit corporation will be a membership corporation with one (1) class of members as provided in the corporation's Bylaws.

ARTICLE VI

Directors of the nonprofit corporation shall qualify and be elected in the manner provided by the Bylaws.

ARTICLE VII

The address of the initial registered office of the corporation is as follows:

ARTICLE VIII

The initial Board of Directors shall be four (4). The number of directors may be increased as provided in the Bylaws. The names and addresses of the persons who are to serve as directors until the first meeting of the nonprofit corporation or until their successors are elected and qualified are:

ARTICLE IX

The nonprofit corporation shall have all the powers granted nonprofit corporations under the laws of the State

of Idaho. However, notwithstanding anything herein to the contrary, the nonprofit corporation shall exercise only such powers as are in furtherance of the exempt purposes of organizations set forth in the subsection of section 501 (c)(3) of the Internal Revenue Code of 1954, under which the corporation chooses to qualify for exemption, as the same now exists or as it may be amended from time to time.

ARTICLE X

In the event of the dissolution of the nonprofit corporation, no member shall be entitled to any distribution or division of its remaining property or its proceeds and the balance of all money and other property received by the nonprofit corporation from any source after the payment of all debts and obligations of the nonprofit corporation, shall be used or distributed exclusively for the purposes within the intendment of Section 501(c)(3) of the Internal Revenue Code of 1954, as the same now exists or as it may be amended from time to time.
