ARTICLES OF INCORPORATION

of

BRUCE M. PERRY, P. A.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is Bruce M. Perry, P. A.

II.

The corporation is to have perpetual existence.

III.

The corporation is organized to engage in the practice of law and to engage in any lawful activities not prohibited to a professional corporation by applicable laws and regulations.

IV.

The authorized capital of the corporation consists of a single class of stock. The total number of authorized shares is 1,000 with a par value of \$1.00 and an aggregate par value of \$1,000.

V.

Shares of stock of the corporation may be owned only by the corporation or by an individual duly licensed by the State of Idaho to practice law.
