ARTICLES OF INCORPORATION

BIG STEP MINING COMPANY, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being of full age, and all citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Business Corporation Act of the State of Idaho, and to that end we hereby adopt the following Articles of Incorporation:

ARTICLE I. The name of the corporation shall be BIG STEP MINING COMPANY, INC..

ARTICLE II. The purpose of the corporation is to purchase, locate, lease, or otherwise acquire mines, mining claims, mining rights, and lands and any interest therein, and explore, work, exercise, develop, and turn to account the same; to quarry, mine, smelt, refine, dress, amalgamate, and prepare for market, ore metal and mineral substances of all kinds, and to carry on any other operations or business which may seem necessary, convenient, or incidental to any of the objects of the company; to buy, sell, manufacture, and deal in minerals, plants, machinery, implements, conveniences, provisions, and things capable of being used in connection with the mining or other operations of this corporation, or required by workmen and others employed by the company; to construct, carry out, maintain, improve, manage, work, control, and superintend, any roads, ways, railways, bridges, reservoirs, watercourses, aqueducts, furnaces, mills, crushing works, hydraulic works, factories, warehouses, and other works and conveniences which may seem necessary, convenient, or incidental to any object of the company and to contribute to subsidize, or otherwise aid or take part in any such operations.

ARTICLE III. The period of existence and the duration of the life of the corporation shall be perpetual.

ARTICLE IV. The principal place of business and the location and post office address of its registered office shall be Nordman, Idaho.

ARTICLE V. The stock of the corporation is divided into 500 shares of common stock at \$100.00 par value each.

ARTICLE VI. The total authorized number of par value shares is 500. The aggregate par value of the total authorized number of par value shares is \$50,000.00.
