THIS CERTIFICATE OF CANCELLATION of Limited Partnership is made and entered into the 31st day of October, 1982, by and between LORIN E. PETERSON, SR., Limited Partner, and LORIN E. PETERSON, JR., General Partner.

WHEREAS, Lorin E. Peterson, Jr., and Lorin E. Peterson, Sr., entered into an Agreement of Limited Partnership on August 15, 1980. Those parties further subscribed to a "Certificate of Limited Partnership of Peterson Franchises Limited Partnership" which was filed with the Idaho Secretary of State May 25, 1982. Under the terms of the Agreement of Limited Partnership and the Certificate of Limited Partnership of Peterson Franchises Limited Partnership Lorin E. Peterson, Jr., was the General Partner and Lorin E. Peterson, Sr., was the Limited Partner.

WHEREAS, Lorin E. Peterson, Jr., and Lorin E. Peterson, Sr., have entered into an agreement to dissolve and liquidate the partnership effective October 31, 1982. The affairs of the Limited Partnership have been wound up and the assets distributed.

NOW, THEREFORE, the undersigned mutually agree by and between themselves as follows:

1. The name of the Limited Partnership is: Peterson Franchises Limited Partnership.

2. The date of filing of its Certificate of Limited Partnership is: May 25, 1982.

3. The reason for filing the Certificate of Cancellation is: all parties to the partnership agreement have mutually agreed that the partnership should be dissolved. The dissolution of the partnership is complete and its affairs wound up with its assets distributed according to law. There are no creditors of the partnership; the Limited Partner has received full satisfaction of all liabilities of the limited partnership; the General Partner has received full satisfaction of all liabilities of the limited partnership; there were no former partners and therefore no distribution is necessary to former partners in satisfaction of any liabilities; and the Limited Partner and the General Partner have received full return of their contributions and full payment of their various partnership interests.

4. The effective date of the dissolution, liquidation and winding up was October 31, 1982. The effective date of cancellation of the certificate shall be upon its filing.
