

1 Articles of Incorporation of Weiser
2 Water Company.

4 Know all men by these presents, that we
5 the undersigned have this day voluntarily
6 associated ourselves together for the purpose
7 of forming a corporation under the laws
8 of the Territory of Idaho

9 And we hereby certify first, that the
10 name of said corporation is Weiser Water
11 Company.

12 Second, That the purposes for which it
13 is formed is for conveying water for mechan-
14 ical, and other useful purposes, and for
15 the construction and operation of Irriga-
16 tion ditches and canals and to hold
17 occupy and use all necessary lands,
18 allowed by law, in connection therewith

19 Third, That the place where its principal
20 business is to be transacted is Weiser City
21 in Washington County Idaho Territory

22 Fourth, That the term for which it is to
23 exist is fifty years from and after the
24 date of its incorporation


25 Fifth, That the number of its Trustees

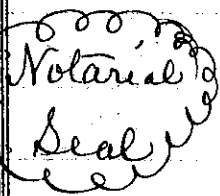
