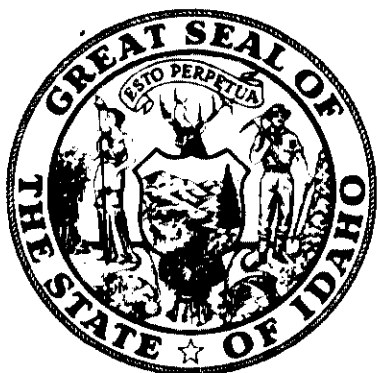

**ARTICLES OF INCORPORATION
OF
ILOWAN'S CHILDREN, INC.**

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following articles of incorporation:

**ARTICLE I
NAME OF THE CHURCH**

The name of the corporation is ILOWAN'S CHILDREN, INC. (the "Church").

**ARTICLE II
STATEMENT OF NONPROFIT STATUS AND EXISTENCE**

The Church is a nonprofit corporation and shall have perpetual existence.

**ARTICLE III
PURPOSES OF THE CHURCH**

The purposes for which the Church is organized are exclusively for religious and other charitable purposes within the meaning of Internal Revenue Code Section 501(c)(3), as amended, or the corresponding provisions of any future law.

ARTICLE IV
REGULATION OF INTERNAL AFFAIRS

Provisions for the regulation of the internal affairs of the Church, including provisions for the distribution of assets on dissolution or final liquidation, are as follows:

1. Inurement. No part of the net earnings of the Church shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the Church shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III above.

2. Legislative and Political Activities. The Church shall not (i) devote more than an insubstantial part of its activities to or attempting to influence legislation by propaganda or otherwise, (ii) directly or indirectly participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office, or (iii) have objectives or engage in activities which characterize the Church as an "action" organization as defined in regulations under Internal Revenue Code Section 501(c)(3), as amended, or the corresponding provisions of any future law.

3. Prohibited Activities. Notwithstanding any other provision of these Articles, the Church shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

4. Distribution of Assets on Dissolution. Upon the dissolution of the Church, the assets of the Church shall be distributed in accordance with Internal Revenue Code Section 501(c)(3), as amended, or the corresponding provisions of any future law (i) for one or more exempt purposes, (ii) to the Federal government for a public purpose, or (iii) to a state or local government for a public purpose.

ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Church is 1205 N. 13th Street, Boise, Idaho 83702, and the name of its initial registered agent at such address is Alice Elizabeth Westin.

ARTICLE VI
INITIAL BOARD OF DIRECTORS

The number of Directors constituting the initial board of Directors of the Church is five (5), and the names and addresses of the persons who are to serve as the initial Directors are:
