ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF BANNOCK COUNTY VETERANS MEMORIAL ASSOCIATION INC-

CORPORATE AUTHORIZATION

We, Howard W. Mitchell, President, and Nancy Albertson, Secretary of Bannock County Veterans Memorial Association, a non-profit corporation, created under and by virtue of the laws of the State of Idaho; said non-profit corporation being located in the City of Pocatello, County of Bannock, State of Idaho, do hereby certify that the following resolution was adopted by unanimous vote by the elected Trustees, and ratified by unanimous vote of the Board of Directors, at a meeting held on Monday, the 18th day of March, 1996, at the corporate offices at the Memorial Building, 300 N. Johnson Avenue, Pocatello, Idaho. At the time and place of said meeting, the membership also voted unanimously to adopt the resolution, with 18 votes cast in favor of the resolution, and 0 votes cast against the resolution.

BE IT RESOLVED, that the number of Trustees who shall have the management of the affairs of this corporation shall be Ten (10), nine of whom shall be elected annually to serve for a period of One (1) year, or until their successors have been duly elected and qualified. The tenth Trustee will normally be the immediate, elected Past President of the Bannock County Veterans Memorial Association.

TO EFFECT this change, the Articles of Incorporation be amended to read as follows:

Paragraph 6:

"6. That the number of Trustees who shall have the management of the affairs of this corporation shall be Ten (10), nine of whom shall be elected annually to serve for a period of One (1) year, or until their successors have been duly elected and qualified. The tenth Trustee will normally be the immediate, elected Past President of the Bannock County Veterans Memorial Association.
