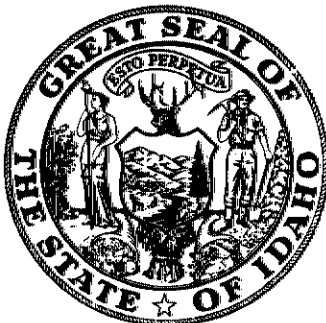

ARTICLE ONE

NAME

The name of the corporation is CORPORATE DYNAMICS, INC.

The duration of the corporation shall be perpetual.
