AMENDED ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That the Articles of Incorporation of Boise Chamber of Commerce, dated the 7th day of Jaruary, 1925, and filed on the same date with the Secretary of State of the State of Idaho, and recorded in Book A-18 of Domestic Corporations, pages 25 and 26, Records of the State of Idaho, under Chapter 195 of the Idaho Compiled Statutes, 1919, as amended, and the laws of the State of Idaho, relating to the organization of corporations where pecuniary profit is not the object, are hereby amended to read as follows:

FIRST

That the name of this corporation is and shall be BOISE CHAMBER OF COMMERCE.

SECOND

OBJECTS AND PURPOSES

The objects and purposes for which this corporation is

- (a) To advance the agricultural, commercial, industrial, educational, and civic interest of the City of Boise, County of Ada, and its surrounding territory;
- (b) To buy, lease, contract for or acquire in any lawful manner, to process, sell or otherwise dispose of property, both real, personal or mixed, wherever situate; to take, hold and convey title to and improve real property by building, repairing or otherwise; to take, receive, acquire, hold, transfer and dispose of monies, donations, contributions, endowments, bequests, devises, securities, and all other species of property; to exercise any and all of the powers of the holders of such securities, including the right to vote with respect

thereto, with power to designate some party for that purpose from time to time to the same extent that natural persons might or could do; and generally do all acts and things designed to protect, improve, preserve or enhance the value of any of the assets of this corporation;

- (c) To pledge, mortgage, encumber or lease any or all of its property to secure its debts and obligations; to borrow and loan money upon any form of security and to give and take mortgages, deeds of trust, assignments and pledges of every kind and character;
- (d) To have and to exercise all powers and to do and perform all acts and things which shall or may be necessary, proper or desirable; to conduct any and all of the business and carry out the objects and purposes for which this corporation is formed or which may be incident thereto;

The statement of objects and purposes specified above and enumeration thereof shall not limit nor restrict in any manner the general powers now or hereafter conferred upon this corporation by the laws of the State of Idaho.

THIRD

LIMITATIONS

The Boise Chamber of Commerce in its activities shall be nonsectarian and shall take no direct part in nor directly lend its influence or facilities to the nomination, election or appointment of any candidate for elective office in the City, County, State or National Government.

FOURTH

PLACE OF BUSINESS

The principal place of business and the business office of this corporation shall be maintained in the City of Boise, County of Ada, State of Idaho.

<u> FIFTH</u>

DURATION

This corporation is to have perpetual existence.

SIXTH

NO CAPITAL STOCK

This corporation is organized solely for general welrare and non-profit purposes. There shall be no capital stock in this corporation, nor shall any of its funds be donated to any society, association, partnership or other organization for pecuniary gain. Members of the corporation shall not be individually or personally liable for the debts or obligations of the corporation, and the respective rights of the members and the interest of each shall be equal.

SEVENTH

McMbersuip

The membership requirements and qualifications in this corporation shall be set forth in the By-Laws.

EIGHTH

BOARD OF DIRECTORS

The corporate powers of this corporation shall be vested in a Board of Directors in such number as may be set forth in the By-Laws, but which shall consist of not less than fifteen nor more than twenty-seven directors.

NINTH

OFFICERS

The officers of this corporation shall be as set forth in the By-Laws.

TENTH

BY-LAWS

The Board of Directors of this corporation shall adopt appropriate By-Laws designed to further and enhance the objects and purposes for which this corporation is organized, and the Board of Directors shall have the power to make, alter, amend or repeal such By-Laws as the Board may determine proper for the management and operation of the affairs of this corporation.

ELEVENTH

AMENDMENTS

These Articles may be amended by a two thirds vote of the membership of the Boise Chamber of Commerce, which may be conducted at any annual or special meeting called for that purpose, or by written ballot.

CERTIFICATE OF AMENDMENT

WE, THE UNDERSIGNED, RAYMOND E. STRAWN and ROCER B.

McGINNIS, respectively the President and Secretary of the Boise
Chamber of Commerce, a non profit corporation, do hereby certify
and declare that the Articles of Incorporation of said corporation were duly amended by more than two-thirds of the voting members by written ballot after due notice thereof, by mailing on
the 26th day of September, 1957, a copy of the foregoing amendments
to each member, together with written ballots for affirmative or
negative vote thereon; that said ballots were returnable to the
office of said corporation on the 4th day of October, 1957; that
thereafter on the 9th day of October, 1957, at a regular meeting
of the Board of Directors, at which a majority of all the members
of said Board were present and voted, the foregoing Articles of
Amendment were duly adopted, ratified and confirmed by unanimous
adoption of the following resolution:

"RESOLVED That the Articles of Incorporation of the Boise Chamber of Commerce are hereby declared to be amended in accordance with the proposed Articles of Amendment mailed to the members of the Boise Chamber of Commerce on the 26th day of September, 1957, a copy of which proposal is attached hereto pursuant to a more than two-thirds affirmative vote of the voting members, to wit, 243 affirmative and 3 negative, pursuant to written ballots returned on or before the 4th day of October, 1957;

"BE IT FURTHER RESOLVED That the President and Secretary of the corporation be, and they hereby are, authorized and directed to make, execute and acknowledge the required certificate of amendment under the corporate seal of this corporation, embracing this resolution, and cause such certificate to be filed and recorded in the manner required by law,"
