ARTICLES OF INCORPORATION

ON

CENTRAL IDAHO GOLD MINES, INC.

We, the undersigned persons, residents of the States of Idaho and Washington and citizens of the United States, hereby associate ourselves for the purpose of forming a corporation, and for that purpose execute these articles in triplicate.

I

The name of this corporation shall be CENTRAL IDAHO GOLD MINES. INC.

II

The objects and purposes for which this corporation is formed shall be and are: To purchase or otherwise acquire, own, hold, sell, transfer, let, encumber, improve, or otherwise deal in real and personal property, and to make and perform contracts of every kind and description furthering any of its objects; to search for, prospect and explore for ores and minerals, and to locate mining claims, grounds or lodes, or acquire mining and mineral rights in the United States of America or the territories thereof, or in foreign countries; to mine, cuarry, work and develop mining grounds, claims or lodes or mining or mineral rights; to crush, concentrate, smelt, refine, dress, amalgamate and prepare for market ores, metals, or mineral substances of all kinds, and to do all other acts and things necessary or conducive to the company's objects, including the erection of buildings or works and the installing of machinery, and appliances of every description whenever required; to mortgage any mining grounds, claims, or lodes, or any mining and mineral rights, or other property belonging to the company, and to issue notes and bonds of the company whenever it is determined to do so.

And to contract for, own, improvem manage, control, and superintend roads, ways, private railways, reservoirs, water courses, ditches, aqueducts, saw mills, crushing mills, mill sites, electrical works, lines and power dams, warehouses and other works and conveniences which may be necessary directly or indirectly in connection with the objects and purposes of the company, and to contribute, subsidize, or otherwise to aid or take part in any such operations. To sell, purchase, acquire, and to hold personal property in all forms, including stock in other companies. To carry on a general mining business. To do any and all things or acts, and to exercise any and all other powers which a copertnerphip or a natural person could do and exercise which now or hereafter may be authorized by law, and to purchase, own, vote, sell or hypothecate the stock and bonds of other corporations.

The principal place of business of this corporation shall be at the mine of the company near Grangeville, Idaho County, Idaho.
