ARTICLES OF INCORPORATION

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation:

 $ar{ ext{ARTICLE}}$ $ar{ ext{ONE.}}$ NAME. The name of the corporation is XIT Corporation.

ARTICLE TWO. PURPOSES. The purpose of the corporation is to engage in ranching and farming operations and to further engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE. DURATION. The period of duration of the corporation is perpetual.

ARTICLE FOUR. REGISTERED OFFICE AND REGISTERED AGENT. The address of the corporation's initial registered office in the State of Idaho is Route B, Box 139, City of Bruneau, County of Owyhee, State of Idaho 83604. The name of the corporation's initial registered agent at such address is Kim Astle.

ARTICLE FIVE. STOCK. The total authorized number of par value shares of stock is 10,000. The aggregate par value of the total authorized number of par value shares is \$10,000.00.

ARTICLE SIX. NON ASSESSABILITY OF STOCK. The holders of stock of this corporation shall not be held individually responsible as such for any debts, contracts, liabilities or

engagements of the corporation, and shall not be liable for assessments to restore impairments in the capital of the corporation; nor shall stock of this corporation be liable to assessment for any purpose.

ARTICLE SEVEN. DIRECTORS. The number of directors constituting the initial board of directors is three and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are:

annexed inventory, as hereinafter provided for, to offer in writing to sell to the board of directors the number of shares of the capital stock held by them to such person or persons as the board of directors shall designate by a resolution duly passed at and for the same sum per share as is determined by the parties to be the net worth of the corporation divided by the number of shares issued for the said corporation.
