One Thousand Nine Hundred Fifty-two and is duly recorded on Film No. 76 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 29-103, 29-1101 and 29-1102, Idaho Code, Annotated.

ARTICLUS OF INCORPORATION OF

"GERESEE COMMUNITY FIRENEN, INC."

KNOW ALL HEN DY THESE PRESENTS:

States, and citizens and residents of the State of Idaho, and of full age, do hereby associate ourselves together for the purpose of forming a benevolent corporation, pursuant to Chapter 11 of Title 30, Idaho Code, and under the laws of the State of Idaho applicable to such corporations, and we nereby adopt and certify the following Articles of Incorporation:

ARTICLE L.

The name of this corporation shall be the "Genesee Community Firemen, Inc."

ARTICLE II.

The objects and purposes for which this corporation is formed are the following:

- 1. To operate and maintain a voluntary fire department for the City of Genesee, in Latah County, Idaho, and the rural area adjacent to the City of Tenesee, Idaho, with the objective of preventing, controlling and fighting fires in such city and vicinity, and to maintain an educational program in fire provention and control.
- 2. To erect and maintain any facilities desired by the membership of this corporation suitable for housing the equipment, machinery and supplies of such organization, or of the City of Geneses, or of the raral fire district adjacent thereto, and to provide and maintain suitable facilities as a meeting place for the membership of this organization and to maintain recreation and social quarters for such membership.
- 3. To receive funds by donations, bequests, earnings of the membership or otherwise, and to hold, invest and disburse all such funds.
- 4. To acquire, sell and dispose of real or personal property and to borrow money and, when necessary, to pledge, hypothecate or mortgage the property of said corporation as security for the payment of any money borrowed for the use and benefit of such corporation.
- 5. Without limitation, to exercise all the powers granted by law to corporations of this character, and to do each and

everything necessary, suitable, useful or advisable for the accomplishment of any one or more of the objectives of this corporation, or to accomplish such objectives as shall, from time to time, appear to be beneficial and expedient to the best interests of said corporation.

APTICLE III.

The registered office, place of business and Post Office address of this corporation shall be Cenesee, Latah County, State of Idaho.

ARRICLE IV.

The existence of this corporation shall be perpetual from and after its incorporation.

ARTICLE V.

There shall be no capital stock, and no shares of stock issued, for or on behalf of this corporation, or in its name. Pecuniary profit is not and shall not become an objective of this corporation.

ARTICLE VI.

scribing their name to these articles, the directors herein named, and such other persons as shall aid the corporation, contribute to its funds, accept its articles and by-laws, together with the regulations adopted thereunder, and who are elected to membership by the members or by the board of directors. Each member shall have one vote, and no more.

ARTICLE VII.

The directors of this corporation shall be such number of persons, not less than five, nor more than thirty-five, as may be, from time to time, prescribed by the by-laws, and until the first meeting and organization of the corporation, the following persons shall serve as directors of said corporation, to-wit:

That a meeting of the members of the voluntary association, known as the "Genesee Community Firemen, Inc.", was duly and regularly called to convene at the Firemen's Hall, in Genesee, Idaho, at the hour of 8:00 o'clock P.M., on the 15th day of August, 1952, and all members of said association were present.
