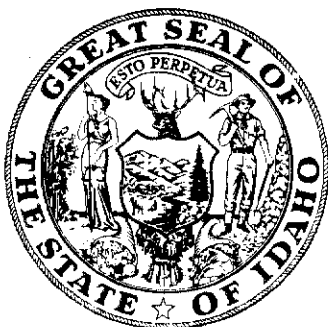

**ARTICLES OF INCORPORATION
OF**

Article I

The name of this corporation is Net Adventure Incorporated

Article II

This corporation is organized to provide Internet® consultation services and to transact such other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

Article III

1. The total authorized capital stock of this corporation is 10,000 shares of common stock, each share having a par value of \$1.00.
2. In the event a shareholder or a shareholder's duly authorized legal representative desires to transfer all or any portion of the shares of stock of this corporation held in the name of the shareholder, a pro rata portion of such shares shall first be offered to each other shareholder of record, who shall have thirty (30) days from the date of the offer to accept the offer and effect a purchase of the shares. Shares not acquired by the remaining shareholders of the corporation shall be purchased by the corporation. The existence of this provision shall be noted conspicuously on every certificate for shares issued by the corporation.


