



ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify that:

PIRST

That the name of this corporation shall be SOUTHERN IDAHO AGRICULTURAL RESEARCHERS AND CONSULTANTS, INC.

SECOND

This corporation is a common stock corporation.

THIRD

The period of duration for SOUTHERN IDAHO AGRICULTURAL RE-SEARCHERS AND CONSULTANTS, INC., shall be perpetual.

FOURTH

The purposes and objects for which this corporation is formed are to conduct agricultural research and to serve as consultants to the agricultrual industry, to purchase land and equipment and to perform all acts necessary to carry out a consulting and research function.

PIPTH

That the location and post office address of the initial registered office of this corporation in the State of Idaho, and its initial registered agent shall be as follows:

SIXTH

That the capital stock of this corporation shall consist of 1000 shares of common stock, having a par value of One Dollar (\$1.00) per share and an aggregate par value of \$1,000.00; each of the shares shall be non-assessable when fully paid for.

The capital stock of this corporation shall not be divided into classes, but shall consist of one class only, that being common stock; that each share of stock shall be entitled to one vote in all matters wherein the shareholders of this corporation shall be entitled to vote, and each share shall in all respects be equal to every other share.

The Capital stock shall be transferred only in accordance with such rules and regulations as are established by the by-laws of corporation, and all restrictions relative to the transfer of shares of stock of the corporation shall be noted on the stock certificate issued by the corporation.

SEVENTH

EIGHTH

That the right and power to adopt, repeal, alter, rescind, and amend the by-laws of this corporation and to adopt new by-laws is hereby expressly conferred upon the Board of Directors of this corporation as provided by Title 30 of the Idaho Code.

That there shall be five (5) members of the initial Board of Directors whose names are as follows:
