KNOW ALL MEN BY THESE PRESENTS: That the undersigned, citizen of the United States of America, over the age of 21 years, has this day submitted these Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Idaho, and certifies in writing:

I.

That the name of the Corporation shall be HARRIS RANCH, Inc.

II.

That the purposes for which this corporation is formed are to engage in the business of farming, ranching, trucking, retail and wholesale business including merchandise and inventory of all kinds and descriptions for sale to the general public or private sector, to sell or purchase its own stock, or to sell and purchase the corporate stock of any corporation; to take, own and hold mortgages or other liens, to own real estate and to dispose of the same in any manner that may be necessary for the benefit of said corporation; to enter into, make and perform contracts of every kind, with any person, firm, association or corporation, municipality, State Government, endorse, discount, execute and issue promissory notes, drafts, bills of exchange, warrants and

other negotiable or transferable instruments, and to secure the same by mortgage of otherwise, so far as amy be permitted by the laws od the State of Idaho, and to do all things necessary and convenient in carrying our the purpose for which this corporation is organized, and especially to exercise all of the powers and rights granted to general business corporations under the laws of the State of Idaho pertaining thereto at the date of the issuance of a certificate of incorporation to this incorporator.
