Articles of Incorporation

The undersigned, acting as incorporator of a corporation under the Idaho Professional Service Corporation Act, adopts the following articles of incorporation for such corporation:

Article I.

The name of the corporation is LAW SERVICE, p.a.

Article II.

The period of its duration is perpetual.

Article III.

The purpose for which the corporation is organized is to practice the professional service of law and to engage in any and all lawful activities of a professional service corporation organized under the Idaho Professional Service Corporation Act.

Article IV.

The aggregate number of member shares, par value is \$100, which the corporation shall have authority to issue is 100.

Article V.

Preemptive rights shall be as provided by law.

Article VI.

There shall be no cumulative voting of shares.

Article VII.
