ARTICLES OF INCORPORATION

DONALD L. TUCKER, A PROFESSIONAL CORPORATION

KNOW ALL MEN BY THESE PRESENTS, that I, a citizen of the United States of America, of full legal age, licensed to practice dentistry in the State of Idaho, having this day voluntarily formed a corporation under the laws of the State of Idaho, and to that end do hereby adopt Articles of Incorporation as follows:

ARTICLE I

The name and duration of the corporation is: <code>DONALD L. TUCKER, a professional corporation</code>, with perpetual duration.

ARTICLE II

The nature of the business, and the objects and purposes to be transacted, promoted and carried on is for the practice of dentistry as authorized by the provisions of Chapter 13 Title 30 of the Idaho Code as now in effect and hereafter ammended.

To have offices, conduct its business, and promote its objects within and without the State of Idaho, in other states, the District of Columbia, the territories and colonies of the United States, and in foreign countries, without restriction as to place or amount.

To do any or all of the things herein set forth to the same extent as natural persons might or could do in any part of the world as principals, agents, contractors, trustees and otherwise, either alone or a company with others.

In general, to carry on all business in connection therewith, not forbidden by the laws of the State of Idaho, and with all the powers conferred upon professional corporations by the laws of the State of Idaho.

ARTICLE III

The location and postoffice address of the corporation is 1221 Michigan, Route 2 Box 161 A, Sandpoint, Idaho 83864.

ARTICLE IV

Donald L. Tucker shall be the initial registered agent.

The person listed in Article VI herein as incorporator, shall constitute the initial board of directors. The principal place of buisness is located at 1221 Michigan.

ARTICLE V

The total authorized number of par value shares is 5,000 and the aggregate par value of the total authorized number of par value shares if \$5,000; the par value of each of said shares of stock shall be \$1.00.
