ARTICLES OF INCORPORATION

OF

BRAMMER FARMS, INC.

We, the undersigned all of whom are of full age and citizens of the United States of America, do hereby voluntarily associate ourselves for the purpose of forming a private corporation under the laws of the State of Idaho; and we hereby set forth, declare, certify and adopt the following Articles of Incorporation.

ARTICLE I. The name of the corporation is BRAMMER FARMS, INC.

ARTICLE II. The purposes specified herein shall be construed both as purposes and powers and shall be in nowise limited or restricted by reference to or inference from the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature not expressed; now, therefore, the object, business, and purposes of this corporation shall be as follows, to-wit:

To purchase and sell farms and to engage in the business of farming and of producing and merchandising all kinds and types of farm crops and products and produce therefrom.

To buy, sell, lease, breed, raise, import, export, and deal in and with, in any manner whatsoever, horses and livestock of all kinds, and to carry on a general business of raising and dealing in and with horses and other livestock, purchasing and/or acquiring, and selling or otherwise disposing of stocks, supplies, equipment, accessories, appurtenances, products and by-products of such business.

To acquire, own, rent, buy as principal, agent or broker, and on commission or otherwise, to buy, sell, exchange, lease, let, grant or take licenses in respect of, improve, develop, repair, manage, maintain and operate real property of every kind and wherever situated. To act as loan broker, and generally do everything suitable, proper and conducive to the successful conduct of a real estate agency and brokerage business in all its branches and departments.

To borrow money, and to make and issue notes, bonds, debentures, obligations, and evidence of indebtedness of all kinds, whether secured by mortgage, pledge, or otherwise, and to secure the same by mortgage, pledge, or otherwise, and generally to make and perform agreements and contracts of every kind and description.

To improve, manage, develop, sell, assign, transfer, lease, mortgage, pledge, or otherwise dispose of, or turn to account or deal with, all or any part of the property of the corporation.

To do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things, incidental to or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.

ARTICLE III. The duration of the corporation is perpetual existence.

ARTICLE IV. The location and address of the registered office of the corporation in the State of Idaho, is in Latah County, with the mailing address being as follows:

ARTICLE V. The total authorized number of par value shares is Twenty-five Hundred (2,500) shares with a par value of One Hundred and no/100 Dollars (\$100.00) per share. The aggregate par value of the total authorized number of par value shares is Two Hundred Fifty Thousand and no/100 Dollars (\$250,000.00).

ARTICLE VI. The stock of the corporation consists of Two Thousand Five Hundred (2,500) shares of common stock, all of the same class, with a par value of One Hundred and no/100 Dollars (\$100.00) per share. At all meetings of the stockholders and at all elections of directors every stockholder of record shall be entitled to one vote for each share of stock standing in his name on the books of the corporation.

unless otherwise determined by the Board of Directors, shall any holder of any shares of the capital stock of the corporation be entitled as such, as a matter of right, to purchase or subscribe for any obligation which the corporation may issue or sell that shall be convertible into or exchangeable for any shares of the stock of the corporation of any class or classes, or to which shall be attached or appurtenant any warrant or warrants or other instrument or instruments that shall confer upon the holder or holders of such obligation the right to subscribe for or purchase from the corporation any shares of its capital stock of any class or classes.
