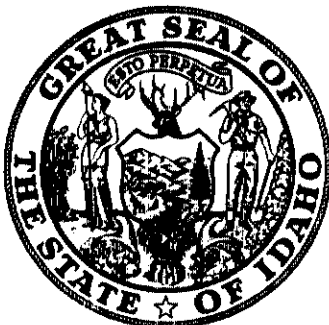
CERTIFICATE OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Paige, Inc. The corporation may also do business under the following names: Paige Emergency Products, Paige Industrial Products, or Flameco.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the purpose of conducting and transacting any or all lawful business in the State of Idaho, including, but not limited to, dealership and distribution of products used by fire fighting agencies, rescues/EMS, law enforcement, corrections, industry, and mining.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100, which shares shall have a par value of \$100.00.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the Bylaws of the corporation as from time to time adopted or amended.

ARTICLE VI

The address of the initial registered office of the corporation is 220 S. Cole Road, Boise, Idaho 83709, and the name of its initial registered agent at such address is Paige LaDawn Hawkes Czykoski.

ARTICLE VII
