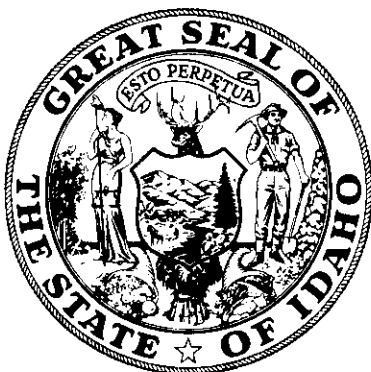

ARTICLES OF INCORPORATION

The undersigned acting as incorporators of a non-profit corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such Corporation:

ARTICLE 1: NAME: The name of the Corporation is Lions Club of Heyburn, Idaho, Inc.

ARTICLE 2: DURATION: The period of its duration is perpetual.

ARTICLE 3: PURPOSE: The Corporation is a non-profit corporation organized for all lawful purposes including but not limited to charitable, civic, educational, social, and patriotic purposes.

ARTICLE 4: REGISTERED AGENT: The address of the initial registered office of the Corporation is Route #2 Box 2315B Paul, Idaho, 83347, and the name of its initial Registered Agent at such address is Sonny Onishi.


