ARTICLES OF INCORPORATION

OF

WEECH WELL DRILLING, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens and residents of the United States of America, and each over the age of 18 years, do by these presents, voluntarily associate ourselves together for the purpose of forming a corporation, as hereinafter stated, pursuant to and under the laws of the State of Idaho, and do hereby execute and deliver these Articles of Incorporation for that purpose.

WE HEREBY SET FORTH, DECLARE AND CERTIFY:

ARTICLE I

NAME

This corporation shall be known as WEECH WELL DRILLING, INC.

ARTICLE II

OBJECTS AND PURPOSES

The objects and purposes for which this corporation is formed are as follows:

- (a) To engage in the well drilling business and the related aspects thereof, including development, repair and maintenance of wells, and the purchase, sale, lease, repair and manufacture of well drilling equipment of every kind and nature. To generally provide well drilling service and to do everything suitable, proper, and conducive to the successful operation of a well drilling enterprise in all its branches and departments.
- (b) To engage in any commercial, industrial or agricultural enterprise, calculated or designed to be profitable to this corporation, and in conformity with the laws of the State of Idaho, or such other place or places and states in which the corporation may, from time to time, conducts its business.
- (c) To purchase, lease, own, sell, mortgage, sublease, and otherwise acquire lands, buildings, easements or property, real and personal, which may be requisite for the purposes of or capable of being conveniently used in connection with

any of the objects of this corporation, and to enter into, make, perform, carry out contracts of every sort and kind, with any person, including the right to become a partner or interested in a joint venture, and to acquire and take over the good will, property, rights, franchises, and assets of every kind, and liabilities of any person, firm, association or corporation, either wholly or in part, and to pay for the same in cash, stocks, bonds of the corporation, or otherwise.

- To organize or cause to be organized under (d) the laws of any state of the United States, or the District of Columbia, or of any territory, dependency, or possession of the United States, or of any foreign country, a corporation or corporations for the purpose of transacting, promoting or carrying on any or all of the objects or purposes for which this corporation is organized, and to dissolve, wind up, liquidate, merge, or consolidate any such corporation or corporations, or to cause the same to be dissolved, wound up, liquidated, merged or consolidated.
- To do all and every thing necessary, suitable, and proper for the accomplishment of any of the purposes or the attainment of any of the objectives, or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act, or acts, thing or things, incidental or pertinent to or growing out of, or connected with the foregoing objects or purposes, or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized.
- The provisions of these Articles shall be construed as purposes and powers, and each as an independent purpose and power in furtherance of, and not in limitation of, the powers which the corporation may have under present or future laws of the State of Idaho, and in such states as the corporation may, from time to time, do business.
- To have and to exercise all rights and powers (q) from time to time granted to a corporation by law.

ARTICLE III

DURATION

The terms and existence of this corporation shall be perpetual.

ARTICLE IV

20 The holder of shares of any class of this corporation shall, upon sale by authorization of the corporation, for cash or 21 shares of the same class, have the right, during a reasonable time to be fixed by the Board of Directors, to purchase shares in proportion to their respective holdings of shares of such class, at such price as may be fixed therefore by the Board of Directors, but at not less than par for par value shares.

All stock, when fully paid, shall be non-assessable. The corporation may purchase its own stock.
