KNOW ALL MEN BY THESE PRESENTS: That the undersigned do hereby establish Helping Hands Custom Cleaning, Inc., as a corporation under the provisions of Chapter 1, Title 30, Idaho Code, and in furtherance of said purpose do hereby certify:

1. **Name.** The name of the Corporation is Helping Hands Custom Cleaning, Inc.
2. **Purposes.** The Corporation is established for the purpose of conducting any and all types of business that may be lawfully conducted in the State of Idaho.
3. **Duration.** The Corporation shall have perpetual existence.
4. **Authorized Shares.** The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares of the par value of \$1.00 each, all of one class, which shall be designated common stock.
