

Amended Articles of Incorporation
 of the Saint Anthony Canal, Improvements and Townsite Co
 and
 Articles of Incorporation
 of the
 St Anthony Union Canal Company

Know all men by these presents;
 That we, the undersigned, have this
 day voluntarily associated ourselves
 for the purpose of forming a
 corporation under the laws of the
 State of Idaho, and we hereby cer-
 tify:

First: That the name of this
 corporation is the St. Anthony
 Union Canal Company.

Second: That the term for which
 this corporation is to exist is
 fifty years.

Third: That the principal
 business of this corporation is to be
 transacted at St Anthony, Bing-
 ham County, State of Idaho.

Fourth: That the purpose for
 which this corporation is organized
 is to buy, sell, convey and improve
 real estate in the State of Idaho
 and to construct and operate canals
 and irrigating ditches, dams and
 head gates, within State.

Fifth: That the capital stock of this corporation is one hundred and fifty thousand dollars (\$150000) to be divided into three thousand shares of the face value of fifty dollars (\$50) each, and the amount of such capital stock actually subscribed by each of the persons hereinafter named is the amount set opposite their respective names, and they are all the subscribers to said capital stock.
