- 4. Article III of the organization certificate with reference to the authorized capital stock, the number of shares into which the capital stock shall be divided, the par value of the shares and the capital stock outstanding, which reads as follows:
 - "III. The amount of capital stock which the corporation is hereafter to have is Ninety Million Eight Hundred Eighty-five Thousand Nine Hundred Forty Dollars (\$90,885,940), divided into nine million eighty-eight thousand five hundred ninety-four (9,088,594) shares, all of which are to be, as heretofore, of the same class and of the par value of Ten Dollars (\$10) each."

- "III. The amount of capital stock which the corporation is hereafter to have is One Hundred Million Dollars (\$100,000,000), divided into ten million (10,000,000) shares, all of which are to be, as heretofore, of the same class and of the par value of Ten Dollars (\$10) each."
- 5. The foregoing amendment of the organization certificate was authorized by unanimous written consent signed by the holder of all outstanding shares entitled to vote thereon.
