ARTICLES OF INCORPORATION

RICHARD F. STARKEY, M.D., P.A.

I, the undersigned, am duly licensed to practice the profession of medicine in the State of Idaho and desire to form a professional corporation pursuant to Sections 30-1301 through 1315 of the Idaho Code for the purpose of rendering medical services and adopt the following articles of incorporation for such corporation.

ARTICLE ONE

NAME. The name of the corporation shall be RICHARD F. STARKEY, M.D., P.A.

ARTICLE TWO

DURATION. The period of this corporative duration shall be perpetual.

ARTICLE THREE

PURPOSE AND POWERS. The purpose for which the corporation is formed is to engage in the general practice of medicine. In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds of real property and security to acquire, own and dispose of real and personal property, and to do all other acts to the extent permitted under I.C.A. 30-1307.

ARTICLE FOUR

PRINCIPLE OFFICE. The address of the initial registered office of the corporation is Post Office Box 427, Mountain Home,

County of Elmore, State of Idaho and the name of this corporation's initial registered agent at the above address is Richard F. Starkey.

ARTICLE FIVE

INCORPORATORS. The name and post office address of each incorporator is as follows:

ARTICLE SIX

CAPITALIZATION. The aggregate number of shares of stock the corporation is authorized to issue is 50,000 shares, which shares shall be common stock having a par value of \$1.00 per share, and each stock shall have a voting right of one vote per share. Stocks shall be issued only to persons who are licensed to practice medicine in the State of Idaho.

ARTICLE SEVEN

SHAREHOLDERS. The name and post office address of the incorporator and the number of shares subscribed by each are as follows:

ARTICLE EIGHT

RIGHT TO AMEND. The corporation reserves the right to amend, alter, change or repeal any provision contained in this certificate of incorporation in the manner now and hereafter prescribed by law, and all rights and powers conferred here on stockholders, directors and officers are subject to this reserve power.

ARTICLE NIN

HOW AMENDED. These articles may be amended by resolution setting forth such amendment or amendments adopted by any meeting of the stockholders by vote of a majority of all the stock of said corporation.


OFFICERS. There shall be no Board of Directors. Until the first annual meeting of the stockholders and the election qualification of the officers the following persons shall serve as officers of the corporation:

ARTICLE ELEVEN

SALE AND ISSUE OF SHARES. The corporation hereby adopts a plan to offer for sale and issue 50,000 shares at \$1.00 per share of common stock pursuant to Section 1244 of the Internal Revenue Code of 1954, as amended, and Section 1.1244 of the Regulations promulgated thereunder, for a period commencing on the date on which these Articles of Incorporation are filed in the office of the Secretary of State and ending two years thereafter or ending on the date when this corporation shall make a subsequent offering of any stock, whichever shall first occur, and the consideration for the said shares to be sold and issued shall be in the total dollar amount of not more than \$50,000.00 at \$1.00 per share, payable in cash or other property (other than stock or securities), and all such stock shall be known as "Section 1244 Stock". The officers of the corporation upon their election shall do all acts and perform all things necessary, convenient or advisable to issue the aforesaid stock in accordance herewith and to carry out the effect of this plan.
