ARTICLES OF INCORPORATION

of

HORNHOCKER WILDLIFE RESEARCH INSTITUTE, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is:

SECOND: The period of its duration is perpetual.

THIRD: The corporation is organized and operated exclusively for charitable, scientific, literary or educational purposes within the meaning of §501(c)(3) of the Internal Revenue Code. The corporation may transact any and all lawful activities for which corporations may be incorporated under the Idaho Nonprofit Corporation Act, §30-306. Not withstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under §501(c)(3) of the Internal Revenue Code.

Specifically, the corporation was formed and now exists to solicit and receive contributions, gifts, grants, devises or bequests of real or personal property or both from individuals, foundations, partnerships, associations, governmental bodies or public or private corporations and to maintain, use and apply the whole or any part of the income therefrom and the principal thereof exclusively for charitable, scientific, literary or educational purposes either directly or by contributions to other

after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its exempt status under \$501(c)(3)\$ of the Internal Revenue Code.
