

AMENDED
ARTICLES OF INCORPORATION
of the
LONG ISLAND IRRIGATION COMPANY
(formerly Long Island Irrigating Company)

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, stockholders of the Long Island Irrigating Company, and representing more than two-thirds of the issued and outstanding Capital Stock of the said Long Island Irrigating Company, pursuant to written notice personally delivered to us, in manner as provided by Section 4756 of the Compiled Laws of the State of Idaho, and more than thirty days prior hereto, having this day assembled ourselves together in stockholders meeting for the purpose of amending our existing Articles of Incorporation, changing the name of our corporation, and increasing its Capital Stock, and to this end having deemed it proper and necessary, and to the interests of all parties hereto,

DO HEREBY CERTIFY:

That the Articles of Incorporation dated March 13, 1890, filed by the Long Island Irrigating Company with the County Recorder of Bingham County, State of Idaho, and subsequently transcribed into Book "A" of Incorporation Records, at page 62, Records of Fremont County, Idaho, are hereby amended and enlarged and that the following are the Articles of Incorporation, and the name of said corporation:

I.

That the name of said corporation shall be the "LONG ISLAND IRRIGATION COMPANY".

II.

That the purposes for which said corporation is formed are:

A- By amendment and re-incorporation, take over, by merger, re-incorporation, as well as by all other lawful means, all of the assets, rights, privileges, franchises, property, both real and personal, of every kind and character and description now owned by the said Long Island Irrigating Company, and to continue as said Company under the name of the "LONG ISLAND IRRIGATION COMPANY", whether as the successor in interest, or by merger, or by amendment to the existing Articles of Incorporation of the said Long Island Irrigating Company.

b- To construct, or otherwise acquire, to own, manage, control or otherwise operate canals and irrigation systems, and particularly that certain canal and irrigation system now known as The Long Island Canal, and which was constructed and has at all times been operated by the Long Island Irrigating Company, and which said canal has its main headgate on the South Bank of the South Fork of Snake River, at a point about one-half mile up-stream from the East one-half mile post of Section thirty-three (33), Township five (5) North, Range thirty-nine (39) East Boise Meridian, and which canal has been in operation since about the year 1880.

c- To acquire, by purchase, assignment, appropriation, or otherwise, water rights of all kinds and description, and to hold, use, pledge, sell or transfer water rights of all kinds and descriptions.

d- To acquire, by purchase or otherwise, title to all real property that may be necessary in the furtherance and the conduct of the business of this corporation, and to pledge and mortgage such property, and to dispose of any and all property, both real and personal, owned by the said corporation, and which is not required for its own use.

e- To conduct and manage an irrigation canal system primarily for the benefit of the stockholders of said corporation, and not for pecuniary profit, and the incorporators hereof do hereby declare that the said corporation has been and is formed, primarily, for the benefit of the said stockholders and not for any pecuniary profit, and that its chief purpose is to distribute to the various stockholders, and such other parties as shall, from time to time, have the right to use the water from said canal, certain water rights and the waters represented by the same, and which have heretofore been decreed to the said The Long Island Irrigating Company, and to do all and every necessary and needful thing in connection therewith.

f- To borrow money, and to pledge, incumber, or in any other manner hypothecate any and all corporate property for the payment of the same.

g- To do any and every thing necessary in connection with the conduct of the business of said corporation, and particularly all things that are permitted under the Laws of the State of Idaho to similar corporations, the said incorporators seeking hereby to take advantage of every provision granted to canal companies under the Laws of the State of Idaho.

III.

That its principal place of business is at Menan, Jefferson County, Idaho.

IV.

That this corporation shall exist for a period of fifty years from and after this date.

V.

That the number of directors shall be five, and that the names and places of residence of those selected for the first year, and until their successors are elected are:

VI.

That the amount of capital stock shall be Sixty Thousand Dollars (\$60,000.00), the same to be divided into Sixty thousand shares of the par value of One Dollar per share.
