We, the undersigned, hereby certify that we are President and Secretary respectively of the Garden Water Company, Limited, and presided at a special meeting of the stockholders of said company held at Teton County Court House in Teton County, Idaho, on the 4th day of April, 1966, at 8:00 o'clock p.m. of said day. That by unanimous vote of the members attending such meeting the following amendment to the Articles of Incorporation was duly accepted, to-wit:

RESOLVED, that Article IV of the Articles of Incorporation of the Garden Water Company, Limited be amended to read as follows:

ARTICLE IV

The corporation shall have perpetual existence.

That Notice of Intention to Amend the Articles of Incorporation was given by publication at least once each week for four weeks in the Teton Valley News, a newspaper published in Teton County, Idaho, the same being the county wherein such meeting was held, which notice complied with the provisions of paragraph 6, section 42-241 Idaho Code, and which notice did state the time and place at which the vote on the amendment of the Articles of Incorporation would be taken, and did contain a summary of the proposed changes in the Articles of Incorporation.
