WE, THE UNDERSIGNED, LAMBERT LEAVERTON AND GWENDOLYN LEAVERTON, PRESIDENT AND SECRETARY RESPECTIVELY OF GEM STATE PLUMBING & HEATING SUPPLY Co., INC., DO HEREBY CERTIFY:

- i. That said Gem State Plumbing & Heating Supply Co., Inc. is a corporation, duly incorporated under the laws of the State of Idaho, with its principal place of business at Blackfoot, Bingham County, Idaho.
- 2. THAT ON THE 13TH DAY OF JANUARY, 1954, AT THE OFFICE OF SAID CORPORATION IN BLACKFOOT, BINGHAM COUNTY, IDAHO, AT A MEETING OF THE STOCKHOLDERS OF SAID CORPORATION, AT WHICH ALL STOCKHOLDERS WERE PRESENT, THE FOLLOWING RESOLUTION WAS DULY PASSED BY THE UNANIMOUS VOTE OF ALL OUTSTANDING STOCK OF THE CORPORATION:

RESOLVED BY THE STOCKHOLDERS OF GEM STATE PLUMBING & HEATING SUPPLY Co., INC., REPRESENTING ALL OF THE SUBSCRIBED CAPITAL STOCK OF SAID CORPORATION IN MEETING DULY ASSEMBLED, THAT THE ARTICLES OF INCORPORATION BE AMENDED AND ALTERED SO THAT ARTICLE | THEREOF, SHALL READ AS FOLLOWS:

THE NAME OF THE CORPORATION SHALL BE "LEAVERTON, INC."

BE IT FURTHER RESOLVED THAT ARTICLE V OF THE ARTICLES OF INCORPORATION OF SAID CORPORATION, AS AMENDED, BE AMENDED TO READ AS FOLLOWS:

ARTICLE V

THE AMOUNT OF THE CAPITAL STOCK OF THIS CORPORATION SHALL BE \$50,000.00, DIVIDED INTO 500 SHARES OF COMMON STOCK OF THE PAR VALUE OF \$100.00 PER SHARE.

RESOLVED FURTHER, THAT THE OFFICERS OF THIS CORPORATION BE, AND THEY ARE HEREBY AUTHORIZED, EMPOWERED AND DIRECTED TO EXECUTE AND FILE ALL DOCUMENTS, AND TO DO ALL THINGS NECESSARY AND PROPER TO EFFECT THE FOREGOING AMENDMENTS.

3. That the total outstanding capital stock of the corporation is 213-5/8 shares of common stock; that no preferred stock has been issued by said corporation; that 213-5/8 shares of stock were present at said meeting and voted thereat; that the total vote in favor of the adoption of said resolution was 213-5/8 shares; that no votes were cast in opposition to said Resolutions.

THAT THE CAPITAL STOCK OF THE CORPORATION WILL BE REDUCED FROM\$75,000.00, DIVIDED INTO 500 SHARES OF COMMON STOCK AT THE PAR VALUE OF \$100.00 EACH AND 250 SHARES OF PREFERRED STOCK AT THE PAR VALUE OF \$100.00 EACH, TO \$50,000.00 BY RETIRING THE 250 SHARES OF UNISSUED PREFERRED STOCK OF THE COMPANY.

5. THAT GEM STATE PLUMBING & HEATING SUPPLY Co., INC. IS NOW, AND AT ALL TIMES HEREIN STATED, WAS SOLVENT AND THE REDUCTION IN CAPITAL STOCK WILL NOT REDUCE THE FAIR VALUE OF THE ASSETS OF THE CORPORATION TO AN AMOUNT LESS THAN THE TOTAL AMOUNT OF ITS DEBTS AND LIABILITIES, PLUS THE AMOUNT OF ITS CAPITAL STOCK SO REDUCED.
