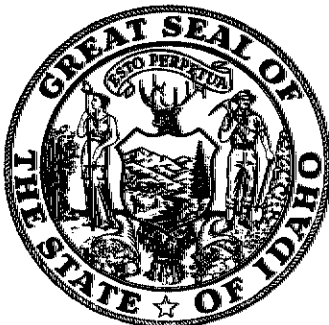

Know all men by these presents, as the undersigned,
as proper persons acting as incorporators of a corporation
under the laws of the State of Idaho, amend and
adopt the following to the previous Articles of Incorporation
of Accurate Property Management, Inc.

First The new name of the corporation is: James Tylor

Second The period of its duration is: Perpetual

Third The purpose of the corporation is amended

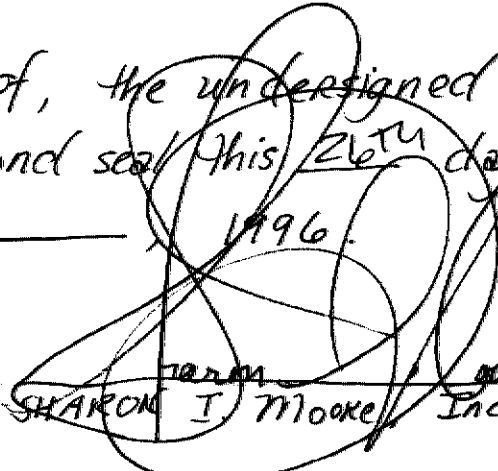

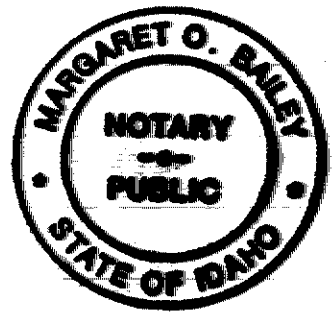

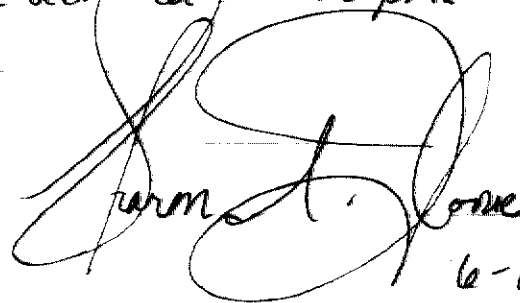
