



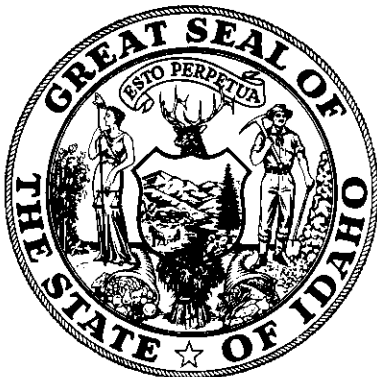
CERTIFICATE OF INCORPORATION
