The undersigned person, being of lawful age, for the purpose of forming a corporation under the provisions of Title 30, Chapter 1, Idaho Code, submits the following Articles of Incorporation to the Secretary of State of Idaho:

Article Six

The corporation is formed for the following purposes:

1. To create, own, hold, conduct and develop a company dealing in all types of real estate , including, but not limited to ownership of aircraft hangers, purchasing, sales, marketing and leasing of all types of real estate, to construct and erect buildings and structures of all types, and to buy, sell, lease, manage, operate, maintain, repair, and/or rebuild same.
2. To act as a Trustee with the highest degree of business intelligence, integrity, and honest dealings, and exercise the powers granted by any Trust instrument with the highest level of fiduciary responsibilities.
3. To create, own, hold, conduct and develop a company dealing in all types to mining operations, including, but not limited to, minerals location, mining claim filings, marketing, production, contractual operations, environmental consulting, environmental protections, security, reclamation and environmental cleanup.
4. To own and hold real estate, To acquire, hold, own, buy, sell, transfer and otherwise dispose of all types of equities, all types of assignments, patent rights, trademarks, copyrights, intellectual properties, licenses, franchises, permits and other evidences of right.
5. To enter into, make, perform, and carry out contracts and agreements of every sort and kind, for any lawful purpose, with any person, firm, association or corporation, state, territory, or country.
6. To organize, maintain and service all types of company divisions, and other companies both within and without the United States.
7. To do any and everything necessary or convenient for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinabove enumerated, either for itself or as agent for any person, firm, or corporation, or other entity.
8. To engage in any other lawful business or operation deemed advantageous or desirable, and to do any and everything incidental to, growing out of, or germane to any of the foregoing purposes or objects conferred by the laws of the State of Idaho upon corporations formed under the Act relating thereto.

Article Seven

The duration of the corporation is perpetual.

The number of directors to constitute the first board of directors is Two (2)
