



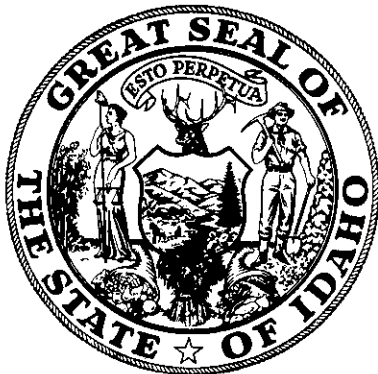
CERTIFICATE OF INCORPORATION

**ARTICLES OF INCORPORATION OF
HOUSEWORK, INC.**

I. NAME The name of the corporation is HOUSEWORK, INC.

II. PERIOD OF DURATION That, subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

III. PURPOSE The purpose of this corporation is to engage in any lawful act or activity for which a corporation may be organized under the Idaho Business Corporation Act other than the banking business, the trust company business, or the practice of a professional permitted to be incorporated by the Idaho Business Corporation Act.

IV. AGENT AND OFFICE FOR SERVICE OF PROCESS The name and address in this state of the corporation's initial agent and initial registered office for service of process are Donald A. Aslett, 253 W. Halliday, Pocatello, ID 83204, the Post Office Address being, P.O. Box 1682, Pocatello, ID 83204.
