# ARTICLES OF INCORPORATION

of the

know all MEN By THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the Laws of the State of Idaho, and for such purpose hereby adopt the following Articles of Incorporation:

### ARTICLE I

The name of said Corporation is the "IMMANUEL SWEDISH EVANGELICAL LUTHERAN CHURCH" of Boise, Idaho.

#### ARTICLE II

The purposes for which said Corporation is formed are: to further the cause of Christianity; to promulgate the teachings of the Bible; to promote the spiritual welfare of the people; to aid in any and all benevolent work; and to buy, acquire, hold, mortgage, sell or dispose of whatever real or personal property said Corporation may require to carry out the purposes herein expressed.

## ARTICLE III

The place where the principal business is to be transacted is Boise, County of Ada, State of Idaho.

## ARTICLE IV

The term for which said Corporation is to exist is FIFTY (50) YEARS.

## ARTICLE V

The number of Trustees of said Corporation shall be five (5), and the names and residences of those who have been selected for their respective terms are as follows:

#### ARTICLE VI

That said Corporation shall not have or issue any capital stock.

### ARTICLE VII

The Directors, or Trustees, of said Corporation shall be elected, as follows: one of said Trustees for three (3) years, two (2) of said Trustees for two (2) years, and two (2) of said Trustees for one (1) year, and as the respective terms of said Trustees expire, a successor shall be elected for the term of three (3) years.

#### ARTICLE VIII

At an election duly called and held at the Parsonage at Boise, County of Ada, State of Idaho, on the first day of February, 1907, an election was had for the purpose of selecting five trustees for said Corporation, and a majority of the members of said Church or Association were present and voted at such election, and the following named person were elected as such Trustees for the respective terms stated:
